What are your data protection rights?

The right to restrict processing - You have the right to request that Our Sustainable Future restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Our Sustainable Future's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
